AGREEMENT AND UNDERTAKINGS

I agree to provide the animal described above (the "animal") with a good home, quality food, clean water, exercise, all necessary medical care including annual check-ups and vaccinations (as advised by my veterinarian) and loving, humane treatment at all times as required by the BCFS.

I understand that the animal has been tested for heart worms (if recommended by a veterinarian) and if negative, is started on heartworm preventative medication. I agree to continue giving the animal heartworm preventative medication for its lifetime in accordance with the direction of the veterinarian.

I understand that the animal is to live in the house or apartment/condominium, unless this is a farm animal. I agree that I will not keep the animal outside except for a reasonable period of time as needed by the animal and that proper shelter and water is available at all times. I agree not to let the animal run at large or to become a public nuisance and to provide all ID tags and licenses necessary for the animal within the jurisdiction where I live.

I will not sell, transfer or give the animal away to any other person, shelter or dealer. I agree not to permit this animal to be used for the purposes of experimentation or inhumane treatment. If I cannot keep the animal or, provide appropriate care for the animal for any reason, I will immediately return the animal only to a representative of the BCFS. I may give the animal to a trusted friend, family member or rescue group only if the BCFS cannot take the animal back into their care and only with prior express and written permission from the BCFS.

I understand that after adopting the animal, all medical and other expenses incurred for the animal are my personal responsibility. The BCFS will no longer be financially responsible for the animal.

I agree that BCFS representatives may examine the animal and/or make inquiries about the animal and examine its living conditions at any time. If, in the opinion of BCFS, conditions are unsatisfactory or if the animal has been mistreated or neglected in any way, I agree that I shall return the animal to the BCFS immediately or, at the BCFS's discretion, at a later date and time specified by the BCFS

I understand that the BCFS makes no representations or guarantees as to the health, disposition or life span of the animal. I understand that the BCFS does not guarantee the behavior or rapid adjustment of the animal into a new home. I agree to hold BCFS and its representatives blameless for any destruction, injury or damage the animal may cause howsoever caused.

By signing this adoption contract, I confirm that I have never been charged with or convicted of animal cruelty under any municipal, provincial/state or federal regulations or laws.

I understand that BCFS is not selling the animal and any money given to the BCFS is a contribution toward the work of caring for animals and is not refundable under any circumstances.

I agree to forever release, discharge and indemnify BCFS and its representatives from any and all actions, suits, claims and demands of any kind arising from this adoption. I understand the BCFS has evaluated this animals behavior to the best of its ability and I agree to hold the BCFS and its representatives harmless from any liability, injury or damages should this animal become a problem to myself or others.

I undertake and agree that should I be unable to continue to give the animal a safe and happy home with me, that I will notify the BCFS as soon as possible and permit BCFS to repossess the animal for re-adoption. Under no circumstances may the adopter relinquish the care and custody of the animal to any other person or locale without prior written permission of BCFS. Non-adherence to this clause will give BCFS the absolute right to repossess the animal immediately. I further undertake and agree that should the animal suffer any ailment, condition or accident which may require euthanasia, that I will contact BCFS immediately and will, if time and the animal's condition allows, permit BCFS to obtain a second opinion and/or speak with the Veterinarian providing such diagnosis. In either event, no donation fees shall be refunded.

Neither this Adoption Contract nor any other document, undertaking or agreement to be delivered by the undersigned furnished to BCFS in connection with this Adoption Contract contains or will contain any untrue statement of fact or omits or will omit to contain a fact necessary to make any statement not misleading. There has been no event or information not disclosed in writing to BCFS which could reasonably be expected to have an adverse effect on the health, comfort, safety or well-being of the animal.
