1. The foster caretaker is prohibited from adopting out the animal(s) without the prior knowledge and consent of the Beaver Creek Farm Sanctuary. INITIAL \_\_\_\_\_

2. To house the fostered animal(s) in my care under safe and sanitary conditions, which meet or exceed all minimum standards as defined by local health, sanitation and animal authorities, and Beaver Creek Farm Sanctuary guidelines. The dog will not be caged in any way for long periods nor will it be tied or chained. An adequately fenced, safe area with shelter will be provided and the dog will have access to this yard/area when not in the house but will not be confined unattended or isolated to this yard/area for extended periods of time." 3. To provide appropriate necessary and essential veterinary care. INITIAL \_\_\_\_\_

4. To make adequate provisions to ensure that the animal(s) is free of parasitic infestations.

5. To provide appropriate food (supplied or recommended by the Beaver Creek Farm Sanctuary, clean water and adequate shelter for the said animal(s).

7. To provide the fostered animal(s) an adjustment period with special understanding, consideration and patience for the animal's stress and fears in a new and strange environment.

8. To give reasonable protection of the fostered animal(s) from the uneducated behaviour of children, and conversely, of the children from nervous and fearful animal(s). The foster caretaker understands and acknowledges that the animal(s) may be dog aggressive and will be sensitive and diligent regarding the safety of other animals and people. INITIAL \_\_\_\_

9. To contact Beaver Creek Farm Sanctuary immediately if any emergency or unmanageable problem arises concerning the fostered animal(s). INITIAL \_\_\_\_\_

10. To absolve the Beaver Creek Farm Sanctuary and its directors of any and all liability for injury or damages to persons and property caused by the fostered animal(s) while in the care of the foster family.

11. If the animal(s) is not spayed/neutered at the time of entering into foster care, arrangements shall be made as soon as veterinary approval is received. Cost for the surgery shall be paid by the Beaver Creek Farm Sanctuary, and all medical records and any medications shall be provided to the foster caretaker. INITIAL \_\_\_\_\_

12. As a foster caregiver I understand that I must update the information and progress of my foster at least once a week. This information should include any aggression - type and frequency, particular fears or dislikes - thunder, men, kids, etc., and any bad habits - digging, barking, etc. This may be done by telephone, email or written letter to Beaver Creek Farm Sanctuary and Foster Coordinator.
